Update on Share Repurchase Program 2021

The enclosed information constitutes regulated information as defined in the Royal Decree of 14 November 2007 on the obligations of issuers of financial instruments admitted to trading on a regulated market.

Mechelen, February 14, 2022 – Telenet Group Holding NV (“Telenet” or the “Company”) (Euronext Brussels: TNET) hereby discloses certain information in relation to its Share Repurchase Program 2021, in accordance with Article 8:4 of the Royal Decree of April 29, 2019 implementing the Belgian Code on Companies and Associations. Under this program, the Company has granted a discretionary mandate to an independent financial intermediary to repurchase up to 1.1 million shares for a maximum amount of €45.0 million for a three-month period, effective as from November 26, 2021.

In the framework of the Share Repurchase Program 2021, as announced on October 28, 2021, the Company repurchased 81,000 common shares in the period from February 7, 2022 up to and including February 11, 2022. The shares were repurchased at an average price of €33.02 per share for a total consideration of €2.7 million.

As a result of the aforementioned market transactions, the Company repurchased in total 914,985 own shares under the Share Repurchase Program 2021 for an aggregate amount of €29.5 million. The repurchased shares under this program will be used to cover future obligations under the Company's share incentive plans or will be cancelled to the extent the repurchased shares would exceed such obligations.

The Company currently holds 5,263,354 own shares (previous update as per February 7, 2022: 5,182,354 own shares), representing 4.62% of the total number of outstanding shares (previous update as per February 7, 2022: 4.55%).
